As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick-up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: -Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife. -Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming. -Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses. -Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems. - Radioactive contaminants, which can be naturally -occurring or be the result of oil and gas production and mining activities.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with IV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. Source of Water: GERMANTOWN Illinois. The Illinois EPA considers Germantown's source water to be susceptible to IOC, VOC, and SOC contamination. This determination was made primarily based on the identification of potential sources and routes of contamination, land-use activities around the wells, available hydrogeological data, and monitoring results. Material reviewed included the Well Site Survey Report, published in 1989. During the surveys of the source water protection area, eight potential sources, routes, or possible problem sites were identified within the 400 foot minimum setback zones, the 1,000 foot Phase I Wellhead Protection Areas (WHPA), and the Phase II WHPA. Two additional sites are outside of the Phase II WHPA. Source of Water: BREESE Illinois EPA considers all surface water sources of community water supply to be susceptible to potential pollution problems, hence, the reason for mandatory treatment for all surface water supplies in Illinois. Mandatory treatment includes coagulation, sedimentation, filtration, and disinfection. In addition, agricultural runoff within the Middle Kaskaskia River Basin contributes to the susceptibility of the Breese intakes.
